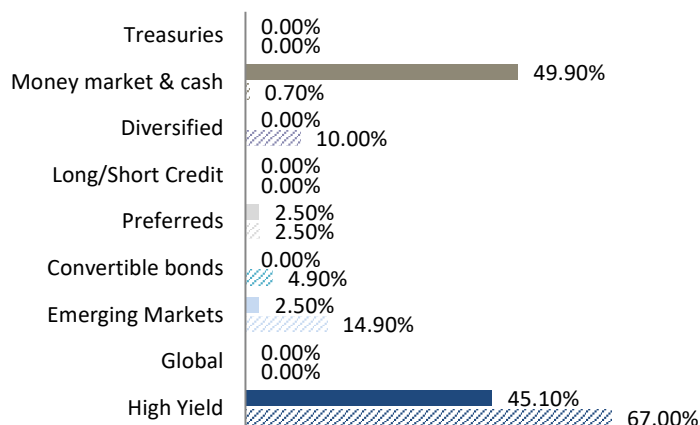

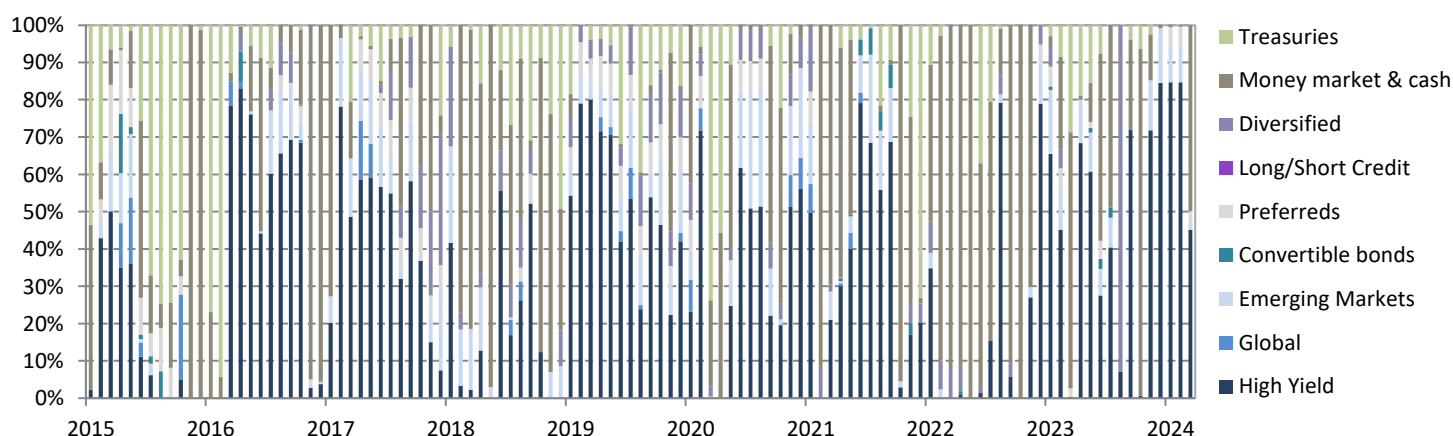

### Monthly investment commentary

---

The Fixed Income Flexible Strategy ("FIS") sub-fund of the Gems Olympia UCITS Fund gained 0,68% in March 2024 (I-USD Unit).

Bond prices gained in March as the Fed reiterated its plan to cut interest rates three times this year despite inflation data once again surprising on the upside. The US consumer price index (CPI) showed inflation rose 3.2% year-over-year, above the 3.1% expectation. The CPI has not declined since reaching 3% in June last year, failing to meet the 2% target that the Federal Reserve has in sight. In addition, the US producer price index (PPI) also came in hotter than anticipated, rising 1.6% yoy against a 1.1% consensus. Fed Chair Powell struck a dovish tone at the central bank's march meeting, stating "it will likely be appropriate to begin dialing back policy restraint at some point this year" and that he wouldn't "overreact" to recent inflation data.

The yield on the 10-year T-Note declined a modest 5bps in March to 4.20%.

The iShares Core U.S. Aggregate Bond ETF (AGG) rose 0.9% for the month. US high yield bonds (HYG) rose 1.1%. Emerging markets bonds (EMB) gained 2% and convertibles (CWB) advanced 2.1%.

FIS ramped up exposure going into April, with additional positions in high yield and EM debt, along with new positions in convertible and municipal bonds.
